INTRODUCTION

This bibliography on the American Assembly topic was prepared by the Reference Branch of the Academy Library at the request of the Department of Political Science. It is not an attempt *at a* complete **and** exhaustive search, but rather is intended to give selections of material in three of the principal sources which might be of assistance to those participating in the Assembly. The material is arranged by subject divisions, and within the subjects by type of material: books, periodicals, and documents. Where possible, Superintendent of Documents classification has been given for each document. It will be noted that those items which **are** House and Senate Reports do not have a document classification. They are filed either in the collected reports found in the Serial Set, or individually by Congress, then by report number.
